A discussion followed; presented by Kelley Goldsmith, with Mark Hardage, Anna Seaborne, Michael Hair and Jim Buckner expressing concerns with the errant Hwy 104 spraying of Conchas residents, and highway spraying instead of mowing and carcinogenic contaminate ingredients entering our lake. The group asked if the water company was performing the necessary tests. Big Mesa is performing tests required by EPA.
